Conditions of Membership - 2022

MEMBERSHIP

Membership of Pevensy Bay Sailing Club runs from 1 January to 31 December of each year.

An early payment discount is offered if cleared payment and membership forms are received before 31 March.

INSURANCE

All registered boats and windsurfers must, while at Pevensy Bay Sailing Club (hereafter mentioned as the Club), be fully insured for third party cover with minimum cover of £2,000,000.

The Club has full Public Liability Insurance with minimum cover of £3,000,000.

MEMBERS' BOATS AND EQUIPMENT

Any personal equipment stored in the Club boat park or members' container is stored entirely at the owner's risk. The Club cannot be held responsible for any loss or damage that may occur.

By storing your equipment at the Club, you are agreeing to the Club procedures for identifying boats and allocation of spaces. This also includes the right of the Club to move or sell abandoned boats or trailers (See sections below: 'Power to remove, sell or dispose of boats and/or trailers' and 'Lien on boats/and/or trailers').

Boat park spaces are allocated on an annual basis. Spaces will be allocated on the basis of application forms received by 31 March each year and at the discretion of the Club Committee. All members requiring boat park spaces should complete section 3 of the renewal form - 'Boat / Windsurfer Registration and Boat Park Application' - regardless of whether they were allocated a boat park space(s) in the previous season.

The Club has installed active video cameras and has a code protected entry gate.

CLUB BOATS AND EQUIPMENT

Using any equipment belonging to the Club is done so entirely at your own risk.

The Club makes regular Health and Safety checks and provides members with a process to report any concerns.

CHILDREN / JUNIOR MEMBERS

Each child registered as a member of the Club must have their parents' consent. In accordance with club regulations, you agree to provide an approved buoyancy aid for each child intent on sailing activities. You agree to be responsible for your registered child's good conduct whilst on Club premises and/or taking part in Club activities. You also agree not to hold the Club liable for any accident or other difficulty in which any such child may become involved. The Club has a nominated Child Welfare Officer and a Child Protection Policy.

PHOTOGRAPHS AND VIDEOS

During the sailing season it is likely that adult and junior members will be photographed or videoed during training, regattas and social events - including by third parties or press. It is Club policy that, unless indicated otherwise on your membership form, these photos and videos will be used as the Club sees fit; this may include photos on the Club wall, in publicity documents, on the website, on Facebook and on other social media.

DUTIES

The Club is a non-profit making organisation run by its members for its members. Therefore for the efficient running of the Club it is essential that all members do their duties. On the membership form there is a space for you to indicate how confident or competent you are for some specific tasks; all inexperienced members will be given support to enable them to do their duty in whatever form that may take. Duties are usually advertised in March for the whole season ahead. If members cannot attend a programmed duty, it is their responsibility to find a replacement. Usually members are planned for an average of three duties per year, but can volunteer to do more should they wish to do so.

The Club uses the on-line Dutyman system to help plan and swap duties where needed accessible via the Club website.

CLUB RULES AND REGULATIONS

This application or renewal is made on the basis of the Club Regulations and Sailing Instructions both of which are available on the Club website. Other than the Club safety boats, only sailing dinghies and windsurfers may be stored and launched from Club premises.

DATA PRIVACY

The information you provide on the membership form will be used solely for dealing with you as a member of Pevensey Bay Sailing Club.

The Club has a Data Privacy Policy. Your data will be stored and used in accordance with this policy.

The Club may arrange for photographs or videos to be taken of Club activities and published on our website, social media channels or the press to promote the Club.

Your consent to your image being used in this way is requested on the first page of the membership form. Your partner's consent is also requested for 'Family' and 'Couple' memberships. Your PARENTAL/GUARDIAN CONSENT is also requested for children under 18 included in 'Family' memberships. If you or any of the individuals listed above later wish to withdraw consent, please contact the Club's membership secretary. By agreeing to your images being used, you agree to assign any copyright or any other right of ownership of these images to the Club.

POWER TO REMOVE, SELL OR DISPOSE OF BOATS AND/OR TRAILERS

In the case of an abandoned or unauthorised boat and/or trailer (as defined below) the Club Committee may:

- (a) move the boat and/or trailer to any part of the club premises without being liable for any loss or damage to the boat and/or trailer howsoever caused;
- (b) upon giving 1 months' notice require the member or former member to collect the boat and/or trailer;
- (c) upon giving three months' notice in writing by registered post to the member or former member at his or her last known address in the Club's membership records sell the boat and/or trailer and deduct any monies due to the Club (whether arrears of subscription or facility fees or boat park fees or otherwise);
- (d) if the boat and/or trailer is unsaleable (in the reasonable opinion of the Club Committee), after giving notice in writing as aforesaid, dispose of the boat and/or trailer in any manner the Club Committee may think fit and deem the cost of doing and any arrears as aforesaid to be a debt owing to the Club by the member or former member.
- (e) the Club reserves the right to charge storage for the boat and/or trailer until such time as the owner collects the boat and/or trailer or until notice has been served under clause (b) and (c) above.

PROVIDED THAT in each case that proper evidence is available to show that all reasonable steps have been taken by the Club Committee to trace a member or former member and that when and if the boat and/or trailer is sold the proceeds of sale (where these exceed the amount of any indebtedness by the member or former member to the club) shall be placed in a bank deposit account and retained against the eventuality of a claim by the owner (whether he or she be the said member or former member) for a period of six years.

The Club Committee shall be entitled to treat any of the following as an abandoned or unauthorised boat and/or trailer:

- (a) a boat and/or trailer located in the boat park and not displaying a valid boat park sticker;
- (b) a boat and/or trailer located otherwise than in its properly allocated space;
- (c) a boat and/or trailer that remains in the boat park for more than one month after any date advised by the Club Committee by which boats and/or trailers must be removed to allow for maintenance works of the boat park;
- (d) a boat and/or trailer which is the property of a member or former member which remains on club premises after any fees payable to the club by any member or former member (whether by way of arrears of subscription or facilities fees, boat park fees or otherwise) are more than one month in arrears;
- (e) a boat and/or trailer which is the property of a member or former member which overstays by more than a month following the termination of the storage agreement;
- (f) a boat and/or trailer which is the property of a former member which overstays by more than a month following the termination of their membership.

LIEN ON BOATS AND/OR TRAILERS

In addition to the powers set out above to move, sell or dispose of boats and/or trailers the club shall have a lien over members' or former members' boats and/or trailers parked on the club's premises in respect of all monies due to the club, whether in respect of arrears of facilities fees or subscriptions or otherwise and shall be entitled to retain possession of the boat and/or trailer until such time as all monies due to the club have been paid in full.

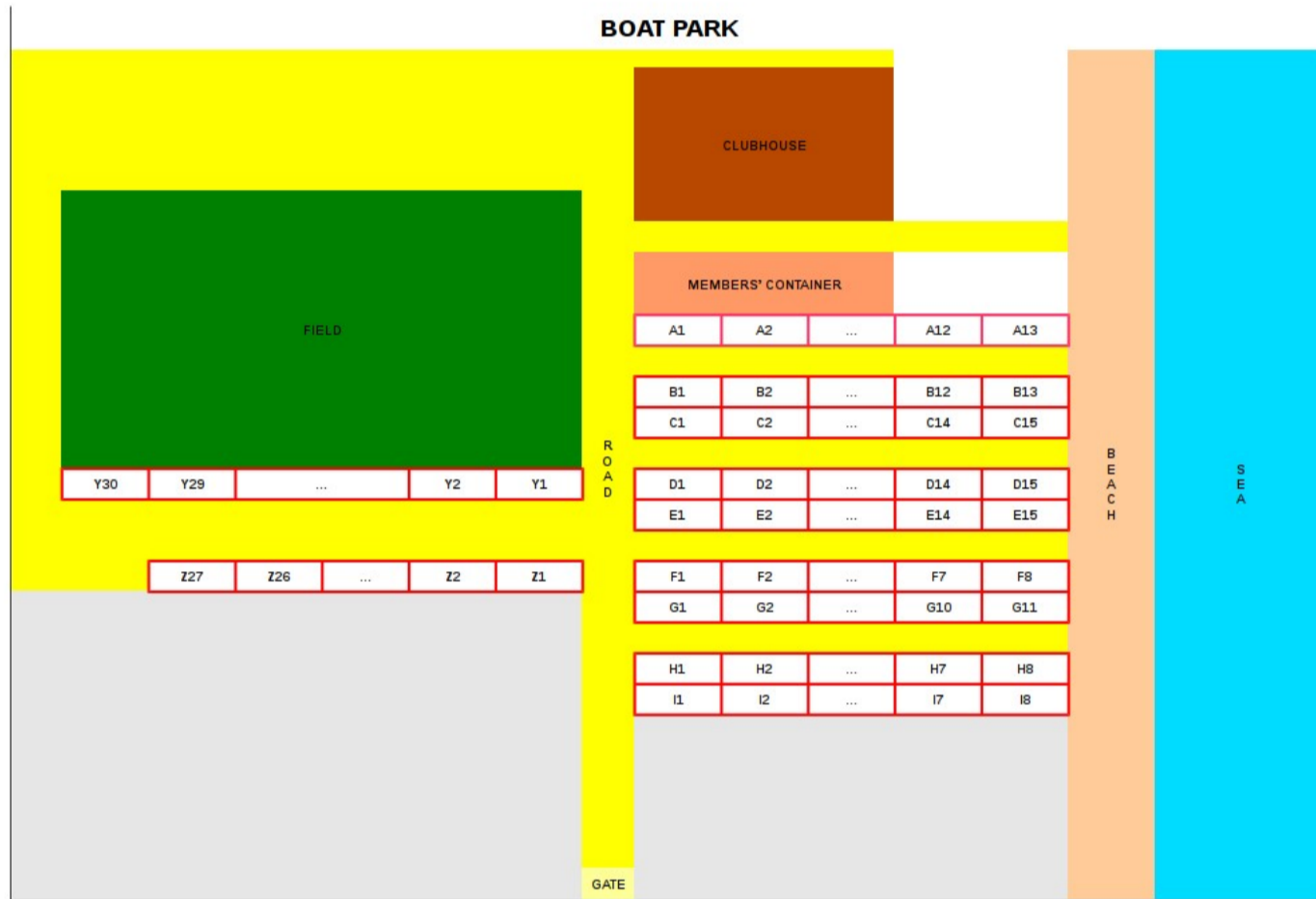
